

TERMS AND CONDITIONS FOR A LOYALTY PROGRAM "AROUND"

These service providers are bound by confidentiality agreements and are prohibited from using Participants' personal data for any purpose other than providing services to the Company.

The Company may also share personal data with third parties in connection with a merger, acquisition, or sale of all or a portion of its assets. In such an event, Participants will be notified via email and/or a prominent notice on the Program website of any change in ownership or uses of their personal data, as well as any choices they may have regarding their personal data.

Data Security

The Company takes reasonable measures to protect Participants' personal data from unauthorized access, alteration, disclosure, or destruction. However, no data transmission over the internet or electronic storage system can be guaranteed to be 100% secure. Participants are responsible for maintaining the confidentiality of their Program login information and are encouraged to choose a strong password.

Program Changes and Termination

The Company reserves the right to modify or terminate the Program or these terms and conditions at any time, with or without notice, in its sole discretion. In the event of Program termination, Participants' personal data will be deleted in accordance with applicable laws and regulations.

Governing Law

This Agreement shall be governed by and construed in accordance with the laws of Curacao.
